Effective June 2, 2009, a new two-year pilot program was approved by the City Commission in which new businesses are allowed to have a temporary grand opening ground sign placed perpendicular to the roadway. The program installs a nine-foot-tall plywood sign which states "Grand Opening" at the top, this sign allows for a 15 square foot area in which the business can advertise on both sides of the panel. The City will work with the business on the correct location and announcement to place on the sign. The pricing is as follows:

30 days: \$500.00

A business must have received their business tax license within the past six months to be eligible for this program.
