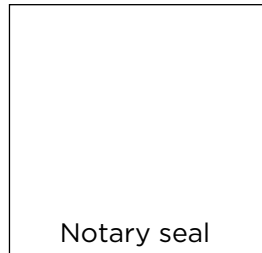

Upon approval by the City Commission, the attached conveyance instrument shall be recorded in the County Records by the City Clerk of the City of Coral Springs.

If the application is in order, it shall be placed on the agenda of the Planning and Zoning Board for public hearing to be held not less than thirty (30) days from the date that the application was filed for those rights-of-way on a Broward County Trafficways.

If the Planning and Zoning Board recommends that the application be granted, the application shall be placed on the agenda of the City Commission for public hearing. Said public hearing, however, shall not be scheduled until thirty (30) days have elapsed since the date of the Planning and Zoning Board action.
