- Application fee of \$770.39 plus petitioner is responsible recordation fee and postage fees which will be billed separately by the City Clerk's office and must be satisfied prior to the execution of the plat waiver
- A current certified ALTA/ACSM land title survey identifying the proposed parcel and existing development, if applicable
- A written statement identifying the sections of the Municipal Code platting requirements from which the waiver is requested and stating fully the grounds for and all facts relied upon in support of the application

**Supporting Documents (cont'd)**

- Letters from all utilities franchised to operate in the City (Florida Power & Light, AT&T, and Blue Stream Fiber) as well as the applicable improvement district, relative to adequacy of proposed easements shown in the plat, including approval of shared easements
- CD containing digital copies of all documents in PDF file
- Two (2) copies of a subdivision plan containing a location map, signature blocks for the City Engineer, and Assistant Director of Development Services, as well as reference to an attached cross indexing of plot titles to metes and bounds descriptions of all plots created by the plat waiver. A Mylar and additional copies of said plan is required upon approval.
- THE SKETCH OF SURVEY MUST BE BASED ON CURRENT TITLE WORK. THE SKETCH MUST INCLUDE A SURVEY NOTE STATING THAT IT HAS BEEN BASED ON CURRENT TITLE WORK ABSTRACTED FOR RESTRICTIONS, RESERVATIONS, AND ENCUMBRANCES.
- Title Certification from a title company licensed in the State of Florida including a Statement of Restrictions, Reservations, Liens and Encumbrances, and including a statement identifying the owner of any residential property included in this plat on May 1, 1979
- Consent of any mortgage holders (consent form attached hereto). JOINDER AND CONSENT OF MORTGAGE SECTION MUST BE FILLED OUT BY EACH MORTGAGE HOLDER. IF THERE IS NO MORTGAGE HOLDER ON THE PROPERTY, OWNER SHALL FILE AN AFFIDAVIT TO THAT EFFECT.
- If the titleholder is a corporation, evidence that the person executing the petition has the authority to act on behalf of and bind the corporation.
