

ORDINANCE NO. 2018-124

AN ORDINANCE OF THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA, PURSUANT TO SECTION 166.041, FLORIDA STATUTES, TO AMEND ORDINANCE 2017-112, FINALIZING AND ADOPTING THE ANNUAL OPERATING BUDGET AND CAPITAL IMPROVEMENT PROGRAM FOR FISCAL YEAR 2017-2018, BY AMENDING EXHIBIT "A", THE ANNUAL OPERATING BUDGET; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in accordance with the City Charter and all the laws of the State of Florida, , the City Commission of the City of Coral Springs finalized and adopted budgets for fiscal year 2017-2018 for the General Fund and Fire Fund, as adopted by Ordinance 2017-112 on September 27, 2017; and

WHEREAS, the City Commission acknowledges that an additional amendment is required to the Annual Operating Budget for Fiscal Year 2017-2018, as designated in Exhibit "A;"

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF CORAL SPRINGS, FLORIDA:

Section 1. Each and all of the foregoing "Whereas" clauses are true and correct and are incorporated herein.

Section 2. That the Annual Operating Budget, approved by the City Commission on September 27, 2017, is amended as designated in Exhibit "A" attached hereto.

Section 3. The City Commission hereby ratifies and confirms all other provisions of Ordinance 2017-112.

Section 4. Repeal of Conflicting Ordinances.

All prior ordinances or resolutions or part thereof in conflict herewith are hereby repealed to the extent of such conflict.

Section 5. Severability.

Should any part, term or provision of this Ordinance be by the courts decided to be invalid, illegal or in conflict with any law of this State, the validity of the remaining portions or provisions shall not be affected thereby.


Section 6. Effective Date.
